About Culture Action Europe

Culture Action Europe (CAE) is the major European network of cultural networks, organisations, artists, activists, academics and policymakers. As the only intersectoral network it brings together members and strategic partners from all areas of culture¹. Culture Action Europe is the political voice of the cultural sector in Europe, the first port of call for informed opinion and debate about arts and cultural policy.

Vision

Culture Action Europe is driven by its belief that culture serves as a fundamental cornerstone for shaping a shared future in an open, globally connected Europe, ensuring the sustainability of our planet, and fostering plural, open, and caring societies.

Mission

Culture Action Europe maintains an ongoing dialogue and knowledge sharing between the European cultural sector and policymakers. CAE advocates for transformative cultural policies that recognise and support culture as a sector in its own right and a catalyst contributing to other sectors.

Four action areas

To achieve its mission, Culture Action Europe focuses on four action areas.

- Advocacy and representation
- Capacity Building (networking, collaboration, discourse)
- Knowledge Production
- Knowledge Sharing

These form our knowledge ecosystem and are part of an impact cycle.

Culture Action Europe network at a glance

At the time of writing (January 2024), Culture Action Europe represents 221 members across Europe and beyond. The network covers 36 countries and brings together 45 transnational cultural networks, 48 national associations, 74 non-membership organisations, 50 individual members and 4 representatives of regions and cities.

At Culture Action Europe, we are committed to fostering an inclusive and equitable membership community. Our membership strategy is designed to ensure that every cultural organisation, regardless of its size or economic context, can actively participate in our vibrant network.

We recognise that the financial resources of cultural organisations can vary significantly across Europe. To uphold the principles of equity and inclusivity, we have tailored membership fees that reflect member organisations size and annual income. In order to make Culture Action Europe accessible for a wider range of cultural practitioners, we have the following membership categories:

Individual members: freelance artists, researchers, cultural practitioners joining the network in their individual capacity

S Members: organisations with an annual income between €0 and €149,999

M Members: organisations with an annual income between €150,000 and €349,999

L Members: organisations with an annual income between €350,000 and €749,999

XL Members: organisations with an annual income over €750,000

Associated Members: representatives of cities, regions or other governmental structures

Supporting Members: Philanthropic foundations, large cultural institutions, arts councils, cultural institutes willing to support CAE aims and activities

Membership fees as of 2024

Over the years, Culture Action Europe has strived to maintain accessible and equitable membership fees for our diverse community of cultural organisations and individuals. However, in light of the economic challenges posed by inflation, we find it necessary to adjust our fee structure to ensure the continued strength and vitality of our network. This adjustment aims to help offset the impact of inflation and ensure that Culture Action Europe remains financially sustainable.

Culture Action Europe Extraordinary General Assembly (9 November, 2023) agreed to increase membership fees as of January 1 2024 and voted in favour of tiered membership fee structure.

Tiered Membership Fees: tiered membership fee system takes into account the gross national income (GNI) per capita (2022) of the country where members are based. This tiered approach acknowledges the varying economic contexts across Europe and seeks to align membership fees accordingly, thus promoting fairness, inclusivity and solidarity.
